**DISCLAIMER:**

- I the undersigned, certify I am the parent/Guardian to the above named child/children
- I certify the child/children are to travel alone and agree to and request the unaccompanied carriage of said child/children
- I also agree to and accept that the following terms are the conditions upon which Integrity Coach Lines agrees to the unaccompanied carriage of the child/children:
  - i. An “unaccompanied child” shall mean a person who is no younger than 10 years and no older than 14 years;
  - ii. The “Carrier” shall mean and include Integrity Coach Lines; it’s servants, its agents and employees.
- The child shall abide by any reasonable instruction made by the Carrier, necessary to the child’s safety and welfare over the course of the journey
- Parents or guardians must be present at the coach stop 20 minutes before the expected time of arrival or departure. If a parent or guardian is not present to collect an unaccompanied child then the child will be taken to the nearest police station. If a police station is unavailable then Department of Child Protection will be called.
- The child must travel with sufficient food or adequate funds for meals whilst en route
- In circumstances of illness, the Carrier reserves the right to take any required action it deems necessary to ensure the comfort and safety of the child, with all costs associated with such action to be borne by the child’s custodial parent/guardian
- The child/children are to be accompanied up to and including the time of departure and are to be met and collected on arrival at the prearranged destination point
- The Carrier will only allow the child off the coach at a scheduled stopping point as detailed in it’s official timetables or any amendments thereto, or as specified in the child’s itinerary
- It is the responsibility of the person collecting the child from the destination point to sign the Carrier’s unaccompanied minor form. If the form is not signed and collected, the Carrier forgoes any responsibility relating to the welfare of the child.
- The Carrier shall not be responsible for any loss or damage incurred by the child as a result of late boarding or failure to board at either the initial boarding point or at any en route stopover point
- An adult guardian must accompany children under the age of 10 years
- I certify that all the information provided by me is true and correct, and that I have read and agree to the above terms.
